

Registration

One form must be filled out for each child registering. Each form must be signed by a parent or guardian and be accompanied by a non-refundable, non-transferable deposit.

Please refer to the camp brochure for session dates and fees. Session dates are fixed and parts thereof may not be applied to other sessions throughout the summer.

Registration Fee

A registration fee, of \$40 for an individual of any age or \$75 for a family, is required in addition to the camp fees. The registration fee is payable only once during the JCC fiscal year of July 1, 2010 – June 30, 2011, regardless of the number of programs enrolled in during that fiscal year.

Payment

A \$1,000 deposit must accompany each camper application submitted. Deposits are not refundable under any circumstance and may not be applied to any other JCC program or activity.

Total payment is due in full by April 21st, but may be paid in advance. Payment plans are available. Please inquire at the front desk.

A limited number of scholarships are available. For information, contact Celia Cuce at x 306. Scholarship deadline is March 15th.

Refunds

Any advance payments, excluding deposits, may be refunded until April 21st. After April 21st, no refunds will be issued. Refunds will not be issued for camp days missed, and days missed may not be made up at any other time throughout the summer.

Discounts

Sibling discounts are available. Please check with your child's Camp Director.

Extensions

Campers may extend their stay only if space is available.

Camp Medical Staff

Medically trained staff is on duty at the JCC during the camp season. JCC camps comply with all New York State Board of Health regulations

Jewish Tradition

Activities at the JCC of Mid-Westchester Camps are complemented with a variety of Jewish learning experiences, including art, nature, music, dance and Shabbat.

Medical Forms

A complete physical is required of all campers prior to the start of the summer. Medical forms will be available on our website at www.jccmw.org and must be completed by both a parent and the camper's physician and returned to the camp office no later than June 1, 2010.

Insurance

Each child is protected by accident insurance during camp hours. The coverage is included in the camp fee and is a supplement to your medical coverage.

Food

All campers receive a hot, kosher lunch each day. Our lunches are catered daily. A menu is available prior to camp on our website.

JCC Camps Policy on Allergies

Many children are allergic to various foods, especially nuts, and even the smallest trace of a substance, such as peanut butter, can cause a potentially fatal reaction. Young children can develop allergies at any time, even when there is no previous history; therefore, JCC Camps aim to provide a "peanut-free" environment. There will be no peanuts or peanut products served anywhere in camp either as lunch or as a snack. **No outside food is allowed in camp.**

Early Arrival/Late Pick-up

Childcare is provided at an extra cost, each morning from 8:00 - 9:00 am daily (*children entering Pre-K and up*) and each afternoon from 4:00-6:00pm should parents require it. **THIS MUST BE REQUESTED IN WRITING IN ADVANCE.** Not applicable to Toward Tomorrow program.
